- 3. - 4. Qualifications and requirements include:
 - (i) Bidders should have **05 years of experience in supplying Firewalls to the State Corporations, Statutory Bodies or for reputed Companies** and should have a valid Business Registration issued by the Government Authority and shall not have been blacklisted.
 - (ii) The manufacturer of the Firewall shall have at least (10) ten years' experience in designing, manufacturing, installing and commissioning and maintenance of Firewalls worldwide.
 - (iii) Bidders should have Manufacturer's Authorization Certificate for the related firewalls.

- (iv) Bidders should have completed at least three (03) Firewall projects over 05 Mn., during the last 05 years at the date of calling quotation.

- 5. A complete set of Bidding Documents which is available in English language can be purchased by interested bidders by submitting a written application on a company/firm letter head to the address: Shroff, Gampaha Wickramarachchi University of Indigenous Medicine, with a non-refundable fee of Rs. 5,000.00, from 25.08.2025 to 11.09.2025 between 9.00 a.m. and 3.00 p.m. during the working days. The documents can be purchased until one day before the deadline for submission of bids.
- 6. Bids must be submitted with a duplicate, and each should be enclosed in separate sealed envelopes, marked as "ORIGINAL" and "DUPLICATE". The two envelopes containing the original and the copy shall then be enclosed in one single envelop and please indicate "Supply, Delivery, Fixing, Installation, Testing, Commissioning and Maintenance of New Firewall System, GWUIM GWUIM/FAD/SUP/AC/08/NCB/25/01" on the top of the left corner of the envelop.

Bids should be deposited by the Bidder in the "Tender Box" available at the Bursar's office, Ground Floor, Administration Building, Gampaha Wickramarachchi University of Indigenous Medicine on or before 02.30 p.m. on 12.09.2025 or sent under registered post to the address The Chairman, Department Procurement Committee (Minor), Gampaha Wickramarachchi University of Indigenous Medicine, Kandy Road, Yakkala before the above deadline.
- 8. Late bids will be rejected. Bids will be opened immediately after the closing of the bids **on 12.09.2025 at 2.30 p.m.** in the presence of the bidders or their representatives who opt to attend in person at the above-mentioned venue. All bids must be accompanied by a Bid-Security as specified in BDS.
- 9. All bids shall be accompanied by a Bid Security of Sri Lankan Rupees One Hundred Thousand (LKR. 100,000.00) paid in cash or unconditional bank guarantee from a reputed commercial bank operating in Sri Lanka and should be valid up to 26 December 2025 from the date of submission of the bid, address to the Vice Chancellor, Gampaha Wickramarachchi University of Indigenous Medicine, Sri Lanka, as per the format specified on page number 55.
- 10. Non-compliance with the above requirements will result in disqualification of the bid without further evaluation.
